Happy Dog Policies

- -Dogs are required to be on a leash at all times in the parking lot and in the lobby.
- -Dogs are required to be on current flea treatment. If at any time a dog is found to have fleas the pet will be isolated and have to be picked up immediately.
- -Prepaid passes expire 6 months from date of purchase and are non-refundable.
- -Any dog not picked up by closing time without prior arrangement will be required to be kenneled and boarded and applicable fees will apply. A phone call can go a long way.

General Release

- -I understand that even though Happy Dogs requires every dog be vaccinated for Kennel Cough with the Bordetella vaccine the vaccine does not protect my dog from every new strain of the virus.
- -I further understand and agree that in admitting my dog(s) to Happy Dogs, that Happy Dogs has relied on my representation that my dog(s) is/are in good health, has no contagious diseases and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog and that I have fully disclosed to Happy Dogs in writing all problems or characteristics of my dog(s) which may affect the handling and care of my dogswhile at Happy Dogs including but in no way limited to the information on this form.
- -I further understand that I am solely responsible for and agree to indemnify Happy Dogs from all liability incurred as a result of an injury and or harm to a person or another dog caused by my dog(s) while visiting.
- -I further understand and agree that Happy Dogs and their staff/volunteers will not be liable for any problems that develop, except in the case of gross negligence or willful misconduct, and I herby agree to release them and hold them harmless from any liability of any kind whatsoever arising from my dog(s) visitation and participation.
- -I understand that my dog may get dirty and matted during play and it is not the responsibility of Happy Dogs to prevent this.
- -I further understand that my dog may be injured or may cause injury to another dog. I have seen and understand the nature of Happy Dogs facility. Dogs are here to play and interact and injuries can/will occur and dogs can spread communicable diseases. I further understand and agree that any illness or injury that my dog(s) may develop while visiting Happy dogs will be treated as deemed best by staff and volunteers of Happy Dogs, in their sole discretion, including choosing a suitable licensed veterinarian, and I assume full liability and financial responsibility for any expenses involved.

- -I give my consent and full authorization to Happy Dogs (agents and employees) to act in my behalf and in my dog(s) best interest, by choosing veterinarian and obtaining emergency vet care at my expense if deemed necessary. I agree to indemnify and hold Happy Dogs (agents and employees) harmless for any and all expense relating to emergency care.
- -I further agree that if my dog(s) is/are not picked up by the end of the regular business day, I hereby expressly authorize Happy Dogs to take whatever action is necessary for the continuing care of my dog(s) and agree to pay all costs upon demand. Further, I understand if I do not pick up my dog(s) within 14 days my dog(s) becomes property of Happy Dogs.
- -I agree my dog(s) may be videotaped< photographed and recorded for unrestricted use in all media and promotions for Happy Dogs.
- -Happy Dogs reserves the right to change, refuse or discontinue service to any dog at any time. Happy Dogs Happy Dogs may terminate my dog's stay at any time for any reason. If my dog's stay is terminated, I agree to promptly pick up my dog(s).
